Speaker - Speaker: Dr. David Clark

Topic - Cultural Resource Management and Archaeological Research at Banshee Reeks Nature Preserve: A 725 acre secret in Loudoun County! The naming of Banshee Reeks dates back to the 1840s and is rooted in Gaelic.

Bio: Dr. Clark received his BA from Ohio State, his Ph.D. from Pittsburgh, and conducted post-doctoral work at the Smithsonian Institution. Archaeological News

Langert '06 Project - Due to the exceptional contributions Chris Ramey made to this emergency data recovery, the site has been re-named the Ramey site (44FX3176). Many times, when I had closed down the excavation thinking that we had pretty well exhausted the site's potential, Chris would ask that I leave a few test pits for him to work on. Each time he

produced new data that caused us to refocus our efforts on more data recovery.

Now, the property owner has started clearing the site. Therefore the systematic excavation is finished. However, we have been able to do several systematic surface collections of artifacts from the newly disturbed soil. We have been fortunate to have had very timely thunderstorms.

We were also able to increase from about 20% to more than 30% the part of the site's core that is to be saved. In doing that we had excellent cooperation from the owner's representatives and the Park Authority's Trails Coordinator, Jenny Pate. This involved moving a trail alignment from cutting thru the core of the site to along the adjacent Lee Road.

In all we excavated about 900, tightly controlled, square feet of our 10,000 square foot grid. If you take away the 3,000 square feet that was saved, we excavated about 13% of the destroyed part of the site. Each artifact was mapped within one square foot of where it was recovered. That kind of control will enable us to reconstruct a much higher percentage of the activity areas than would be recovered from a standard contract excavation. Of course, based on our own preliminary evaluations, not even we would have taken this site to 13% recovery without the enthusiasm of one volunteer, Chris.

The results of the artifact quantity and quality recovered from the excavation pale by comparison with the "grab bag" surface collection from the construction site. The problem with the surface collection is that none of the artifacts can be provenienced so they contribute nothing to the site's internal patterning. They point out, though, what was missed by not excavating the remaining 87%. Had the surface collected artifacts, plus those that will never be recover, been recovered in good context the site would have had a much fuller story to tell about American Indian life.

In summary, we recovered diagnostic artifacts from the Middle and Late Archaic, and the Early, Middle and Late Woodland. Points included Lobate, Morrow Mountain II, Holmes/Bare Island, Susquehanna, Calvert, Hellgrammite, Rossville, Piscataway, Selby Bay, and medium and small sized triangles. Pottery included what appears to be Middle Woodland sandstone and crushed quartz tempered shards, and Early or Late Woodland sand tempered cord marked shards. We also recovered several diagnostic, Late Archaic, soapstone bowl fragments.

Two adjoining blocks (A and I) produced our only jasper concentration. Fortunately we were able to excavate large areas of that part of the site and recovered two jasper points (pictured) and an expended jasper core. The points are of no recognizable type so they could be from any time between Pre-Clovis and Late Woodland.

The surface collection produced several very unusual functional artifacts. The pictured atlatl weight fragment ("wing") is extremely unusual from Fairfax County. If memory serves me I do not remember ever recovering an atlatl weight from more than 30 years of work in the County. Again the credit goes to the non-professionals. It was recovered by the owner's Project Manager from an area our crew had already examined.

We also recovered four examples of an unseal hornfels knife-like tool. The surface collection produced two whole, one almost whole and one fragment of one-piece knives/hand saws. The one-piece tools had distinct handles and blades. I do not recall ever seeing this tool type in Fairfax County. The most prominent examples of this general technology are "Danish daggers," made of flint from the European Neolithic, which, of course our examples are undoubtedly not related. Unfortunately, the Ramey site tools are made of hornfels in which the surface flake scars have weathered off. Therefore, the details of the technology are not preserved.

The excavation was the easy part. Now the hard part begins. All 900+ bags of dry screen residue have to be washed, sorted and catalogued. -- Mike Johnson
