The Archaeology and Collections Branch is very proud of their achievements!

Several members of the Archaeology and Collections Branch (ACB) and CART staff have for the Middle been preparing Atlantic Archaeological Conference. The conference will be held in Virginia Beach, Virginia in March 2017. If vou are planning on attending keep an eve out for ACB and CART archaeologist's presentations. In the field, CART's current excavations have focused on exposing a large, dark stain that is likely the remains of a cellar from a dwelling that predates a standing structure located elsewhere within the park. Artifacts that have been collected range from the eighteenth through early nineteenth century. The full extent of the stain has yet to be exposed; after it is exposed, we will be sampling the feature. Excavations will likely continue well into the New Year in the park. The Fairfax County Park Authority recently underwent reaccreditation inspections for the American Alliance of Museums (AAM). We're extremely proud of everyone's hard work in preparation for the reaccreditation process! Our collections and facilities are in significantly better condition and we will be continuing to work to ensure they meet federal and AAM standards.

Erica (shown in the image), CART's assistant lab director, will be moving on to finish her degree in nursing. We would like to thank Erica for all of her hard work over the past couple of years and we wish her luck in her future endeavors!
