
The month of May will have us on a field trip to Salubria in Culpeper County, with no monthly meeting. Please plan to come on this field trip, it will be worth it!

PUBLIC ARCHAEOLOGY IN
WASHINGTON, DC:
THE SHOTGUN HOUSE PROJECT

Dr. Trocolli will discuss archaeology in DC, but mainly focus on a shotgun house where the DCHPO conducted public archaeology. Dr. Ruth Trocolli is the City Archaeologist for the District of Columbia (DC) in the Historic Preservation Office/ Office of Planning. She ensures DC is in compliance with District and federal laws mandating identification,

documentation, and protection of archaeological resources. A 2015 winner of the Morris & Gwendolyn Cafrtiz Foundation Award, and a 2016 Society for Historical Archaeology Award of Merit, Dr. Trocolliøs duties include reviewing federal and local projects, maintaining the archaeological site files and GIS, and public outreach.

She has hosted numerous interns who have gone on to various graduate programs, The veterans Curation Program, museum positions, and CRM companies throughout the region. She received her doctorate from the University of Florida in 2006, and a BA from Douglass College, Rutgers University (NJ). Dr. Trocolli has been employed as a professional archaeologist since she completed her undergraduate degree, and has even worked on Wall Street (NY) twice ó doing archaeology! She lives in Fairfax County and is married to an archaeologist who happens to be working in the IT field.

The NVC Secretary Nancy Ehlke has been diligently preparing a change to the bylaws regarding chapter committees. Currently, our chapter by-laws specify four standing committees in Article IV, Officers and Committees as follows:

There shall be four standing committees, appointed by the President:

- a. Hospitality: Shall arrange for refreshments at meetings and plan special functions of the Chapter.

CART

Fairfax County Archaeological Research Team

The wet winter weather continues, so CART field team along with volunteers are working hard in the lab, picking through the waterscreen windowscreen samples, cataloging artifacts, and editing reports. Shown in the images are a variety of artifacts recently cataloged, including a dark olive green glass fragment which was flaked and sharpened along one edge.


A warm 70 degree day allowed for the final bags of waterscreen samples to be processed outside. The cool water was refreshing on the warm õspringö day. On one other dry day in February, CART transited in new test units at Site 44FX0704 in the center of the OCPP near the brick foundation which dates to the eighteenth century, though it has been too wet to begin those units. When the final edits on the report for test units at the Enyedi Property at Old Colchester Park and Preserve are complete, CART will return to that section of the Park.



A dry day on 3 March (and hopefully 10 March) a metal detecting survey will be conducted at the current site in western Fairfax County. Though we have finished the large feature excavations, metal detecting in the surrounding area might reveal some other evidence of outbuildings or landscape design at the site.

In the middle of February, the Council of Virginia Archaeologists (COVA), held their winter meeting at the James Lee Center. This organization was founded in 1975 and is dedicated to the preservation and study of Virginiaøs archaeological resources (www.cova-inc.org). Some members toured the JLC Archaeology Lab and saw first-hand our interesting collection of artifacts recovered from almost 40 years of archaeological work in Fairfax Dr. Bernard Means from the Virtual Curation Lab at Virginia Commonwealth University (VCU) 3-D scanned some artifacts from our collections which can be found at: https://sketchfab.com/virtualcurationlab/collections/ fairfax-county-park-authority
