THE BOTTOM: AN AFRICAN-AMERICAN ENCLAVE UNCOVERED

Jessica Kaplan brings to life õThe Bottom,ö one of the oldest African American enclaves in Arlington located along Pimmit Run near Chain Bridge. Through meticulous research in newspapers, Civil War soldiersø drawings, and Southern Claims Commission documents, she provides a window into the lives of its residents. The Bottom was a small community established before the Civil War by free African Americans and offered sanctuary to a group of families struggling to earn a living and create a safe community. The area remained their home through challenging times: war, Reconstruction, Jim Crow, segregation, and suburbanization. The black families were slowly displaced during the first decades of the 20th century. In the 1950s, most of The Bottom became the anchor for an overpass of the George Washington Memorial Parkway.

Jessica Kaplan is a long-time resident of Arlington who has worked as an archivist and freelance historical researcher for more than 20 years. She regularly researches and writes about Arlington history and has written articles for the Arlington Historical Magazine including õ-I Was a Union Manø James and Lewis Marceyøs Civil War Experience.ö She is a member of the Arlington Historical Society.

CART

Fairfax County Archaeological Research Team

Throughout January CART archaeologists continued working hard in both the field and in the lab. Inclement weather this time of year often create more opportunities for CART field technicians to work on new projects in the lab. Archaeologist Melissa has been working through the winter months on scaled drawing of some of the more notable artifacts from Fairfax County Parks. Drawings are a very useful for showing depth and detail that is often lost in photographs, they are then scanned and saved for future reference. Some of the artifacts she focused on include utensils, mended ceramics, a gun cock, and other small artifacts.

Field excavations are ongoing at both the Mount Air Historic Site in Lorton and Riverbend Park in Great Falls. Both projects consist of systematically shovel test pit (STP) surveys across grids established for both parks. We use the artifacts recovered from these surveys to delineate archaeological sites; this way we have a better understanding of resources within the parks in general. If a trail needs to be maintained or realigned in one of our parks, the data from these surveys help guide installation so no cultural resources are lost or compromised.



In the lab, staff and volunteers continue artifact processing, cataloging, and data entry for the artifacts recovered from Riverbend and Mount Air. Assistant Collections Manager Heather created a fantastic new exhibit featuring archaeologically artifacts and museum objects preserved by CART throughout the years. The exhibit focus on the Frederick Colman painting *One of the Family* (1880) and the type of artifacts archaeologists have recovered from eighteenth and nineteenth century sites across Fairfax County. The display can be seen next to the Archaeology Lab in the James Lee Community Center.
